#### **Sub-contractors**

All Sub- Contractors in the marina are required to have liability insurance and workers' compensation insurance in the amount of \$2,000,000. **No** subcontractors are allowed in the Service Yard without proper documentation. All subcontractors are to be billed through the York River Service Department.

As a full-service yard, we extend the privilege to boat owners of working on their own vessels. This is a privilege, and we expect boat owners to perform their own work themselves and in accordance with York River Yacht Haven rules and regulations:

- o Do not move blocks or stands yourself. Yard crew will move stands at your request.
- o Clean your work area daily as there is a \$50 clean-up fee.
- o Please wear safety gear for your health and safety.

- Outside contractors or employees of a yacht owner are prohibited from performing any work on yachts in the service yard.
- Bring your own OHSA approved ladder, grounded extension cords and tools.
- o **Parking:** unload your car and move it to the dock parking lot.
- Spray painting, welding, and sandblasting, in any form is strictly prohibited. Any other activity that has the potential of damaging other boats is also prohibited.
- o Sanding: must be done with a vacuum collection system.
- o It is our policy that all bottom paint, solvents and other supplies be purchased at Yard or Ship's Store.
- o Craftsmen are on timed jobs, if you need help, please ask the service writer or manager, do not interrupt yard employees.
- Yard will monitor all do it yourself customers for compliance with YRYH regulations as well as all state and federal environmental policies.
- o There will be fines for spills/pollutant in the yard.

#### We are a Virginia Clean Marina

Therefore, we must control the use of potentially hazardous materials in our facility. This is the rationale behind our policies of clean up fees and material acquisition. In addition, we charge a 1% environmental fee for all transactions to aid in proper clean up and disposal of toxic and hazardous wastes.

#### **Payment of Service Yard Bills**

Payment is due upon our presentation of your bill for the services you requested. Payment may be made by cash, check or major credit card for your convenience. All invoices must be paid in full prior to launch. Any unpaid balances will accrue interest after 30 days at a rate of 1.83% monthly.

# York River Yacht Haven reserves the right to refuse service on any boat for any reason.

All rates are applicable for regularly scheduled service work. If overtime is requested, it will be billed at 1 and 1/2 times the regular billing rate, and double time for Saturday, Sunday, and holiday. All work will be scheduled, on a first come first served basis.

York River Yacht Haven shall have a possessor lien upon the vessel and its contents as provided by Section 43-32 of the Virginia Code for unpaid sums due or services. It is further agreed that should collection of unpaid sums by an attorney be necessary, an additional fee of **25%** of the unpaid balance, plus costs of the Court, shall be charged on the account.

York River Yacht Haven is not responsible for accidents or injuries to persons or vessels caused by any rented equipment. Vessel owner assumes all liability for persons using rented equipment, his own vessel as well as the vessels around his in the Yard. It is further agreed that the boat owner shall not hold York River Yacht Haven or any of its employees or agents liable for any loss, damage or personal injury caused by any condition while the boat is in the Service Yard. It is agreed that the owner will provide insurance sufficient to protect against any such loss, damage or personal injury to the person or property of the owner or others.
